CubelQ Electronic Signature Technology in Hospitality Industry

The **largest Hotelier in Greece** in terms of accommodation and tourist destinations is using CubelQ Electronic Signature Technology. The Hotelier, through its subsidiaries, manages 73 privately owned hotels in 34 different destinations in Greece. The total number of rooms in the group amounts to 4,100, with the beds exceeding 9,200.

Hotel and Resorts use a number of seasonal employees which need to sign a number of different employment contracts, occupation agreements and statements of work. Such documents containing private and personal data should be managed under General Data Protection Regulation - **GDPR**, the European Union Regulation EU/679/2016 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, in order a proof of consensus from employees for receiving, storing and processing their personal data to be recorder.

Moreover, contracts, agreements and statements should be electronically signed using a legal and uncompromised mechanism which uniquely identify the signees, employer and employee according to Electronic IDentification, Authentication and trust Services - **eIDAS**, the European Union Regulation EU/910/2014 of 23 July 2014.

Such mechanism that covers both GDPR and eIDAS is to use electronic signature technology in the Human Resources and Document Management software implemented for employees to electronically sign contracts, agreements and statements as well as all other related documents.

CubelQ's electronic signature technology is used which includes signotec's real signature pads, signature management software to sign the selected documents and integration services to the Human Resources and Document Management software. **The signature is executed directly via the signature pad**, captured and securely stored in the signed document. Signed documents are then saved by the Human Resources and Document Management software directly in the master documents repository from where they can be retrieved and viewed at any time.

Signature pads that are specially developed and manufactured by signotec, have a large number of RSA security mechanisms and are characterized by their longevity and simple handling. Signature pads together with the signature software capture and stores legally compliant, advanced electronic signature that complies with the specifications of the ISO standards and eIDAS regulations.
